Ok, I spoke to Sandra Neren, and she also called it a clerical error. Angie was the person her firm reported to years ago, and they apparently never changed the filing.

These <u>10-Ks</u> filed with the SEC also appear to be consistent with what Angie has said publicly about her various roles at St. Jude's. There's a brief narrative attached to the one from <u>2012</u>, when she left the VP of Corporate Relations position.

Sorry, the lobbyist disbursement reports seemed like pretty compelling evidence, but there's also overwhelming evidence to suggest they were indeed mistakes.
